## Braille Labels

These pressure sensitive labels allow the Customer Service Engineer or customer to add Braille to almost any copier control console. For some copiers, Braille abbreviations fit right onto or next to the number and feature buttons. For others, a large Braille legend is affixed to the document handler to provide a map of the console layout. These labels are most effective when used on copiers with individual feature selection buttons. (Not recommended for touch screens).
