

Compensation and Human Capital Committee Charter

(Amended as of December 12, 2024)

Purpose

The purpose of the Compensation and Human Capital Committee (the “Committee”) of the Board of Directors (the “Board”) of Xerox Holdings Corporation (the “Company”) is to discharge the responsibilities of the Board relating to compensation of the Company's Chief Executive Officer, Section 16 Officers (as defined below) and other officers who report directly to the Chief Executive Officer; to oversee the evaluation of the Chief Executive Officer and other members of management who are Section 16 Officers or are officers who report directly to the Chief Executive Officer; to oversee the administration of the Company’s executive compensation plans; to prepare a Compensation Committee Report required by the applicable Securities and Exchange Commission (“SEC”) rules; and to consult with the Chief Executive Officer and advise the Board with respect to succession planning regarding Section 16 Officers and Chief Executive Officer direct reports. The Committee shall have such other powers and perform such other duties as the Board may from time-to-time delegate to it in accordance with Article III of the By-Laws of the Company, as the same shall from time to time be amended.

Duties and Responsibilities

1. Review and make recommendations to the Board with respect to executive compensation and executive retirement plans. Executive compensation plans include cash and/or equity payments earned in the short term and/or long term.
2. Annually, review and approve performance goals and objectives, consistent with approved compensation plans, with respect to the compensation of the Chief Executive Officer and all other officers, including the Chairman of the Board if the Chairman is an officer of the Company, who are elected pursuant to Sections 1 and 2 of Article IV of the Company’s By-Laws and who either (i) are designated as Section 16 officers by the Office of the Corporate Secretary (“Section 16 Officers”) or (ii) report directly to the Chief Executive Officer.
3. Annually review and approve a group of peer companies for the purpose of benchmarking executive compensation plans and practices.
4. Annually, oversee the performance evaluation of the Chief Executive Officer, the Section 16 Officers and any other officer who reports directly to the Chief Executive Officer against approved goals and objectives.
5. Based on the evaluation, recommend to the Board the compensation of the Chief Executive Officer, including annual base salary level, annual incentive level, long-term incentive level and related equity grants and any special or supplemental benefits or perquisites. The Chief Executive Officer shall not be present during voting or deliberations on his or her compensation.
6. Based on the evaluation, set the compensation of the Section 16 Officers and any other officer who reports directly to the Chief Executive Officer (including annual base salary level,

annual incentive level, long-term incentive level and related equity grants and any special or supplemental benefits or perquisites).

7. Review and approve employment, severance, change in control, termination and retirement arrangements for the Chief Executive Officer, the Section 16 Officers and any other officer who reports directly to the Chief Executive Officer.

8. The Committee shall have the sole authority to directly appoint, retain or obtain advice from, compensate, evaluate and terminate all consultants engaged to assist the Committee in the evaluation of the compensation of the Chief Executive Officer and senior management. The Committee is directly responsible for oversight of the work of the consultants, including determination of compensation to be paid to such consultant by the Company. The Committee may also conduct or authorize investigations into or studies of matters within the Committee's scope of responsibilities and may retain such independent counsel or other advisers as it deems necessary. The Committee shall have the resources and authority appropriate to discharge its duties and responsibilities, including the sole authority to determine the extent of funding necessary for payment of compensation to any compensation consultant, special counsel, or other advisor appointed to advise the Committee. The Committee shall also have the authority to determine the fees and to direct the Company to pay such fees to such advisors, and to pay any other ordinary administrative expenses of the Committee that are necessary or appropriate in carrying out its duties.

9. Administer and interpret executive compensation plans to the extent required by the terms of such plans, including by approving grants under equity incentive plans.

10. To the extent the Committee deems necessary or appropriate, approve, administer, and amend the Company's other employee benefit plans.

11. In consultation with senior management of the Company, oversee regulatory compliance with respect to compensation matters, including overseeing the Company's policies on structuring compensation programs to preserve desired tax treatment.

12. Review and discuss with the Company's management the Compensation Discussion and Analysis required by the SEC rules to be included in the Company's annual report on Form 10-K, proxy statement on Schedule 14A or information statement on Schedule 14C, or any successor SEC form or schedules (the "CD&A"), and, based on such review and discussion, recommend to the Board whether or not such CD&A be included in such forms or schedules. In addition and as appropriate, review and discuss with management any further disclosures related to executive compensation not contained in the CD&A, but provided elsewhere in the Company's annual report on Form 10-K, proxy statement on Schedule 14A or information statement on Schedule 14C, or any successor SEC forms or schedules.

13. Prepare a "Compensation Committee Report" required by the SEC rules to be included in the Company's annual report on Form 10-K, proxy statement on Schedule 14A or information statement on Schedule 14C, or any successor SEC forms or schedules.

14. Annually conduct an evaluation of its own performance and the adequacy of this charter and, in light of this, consider changes in its membership, charter or procedures. The Committee

shall report to the Board the results of its evaluation, including recommended charter, membership and other changes.

15. Conduct an independence assessment (i) before selecting any new consultants and (ii) annually for of any existing consultants. Such assessment shall include consideration of the independence factors required under SEC and the requirements of The Nasdaq Stock Market LLC (the "Nasdaq Rules").

16. Consider the results of shareholder advisory votes on executive compensation and the frequency of such votes.

17. Administer and carry out its duties under the Company's compensation recoupment policy, including the determination of the amount of, and appropriate means of recovering any, erroneously awarded incentive-based compensation.

18. Establish and monitor compliance with any stock ownership holding requirements or guidelines of the Company that are applicable to the Chief Executive Officer, Section 16 Officers and any other officer who reports directly to the Chief Executive Officer.

19. Review the Company's human capital management function, including but not limited to strategies, initiatives and programs regarding recruiting, retention, talent management and development, employee engagement, and diversity, equity and inclusion.

20. Advise the Board with respect to succession planning regarding the Chief Executive Officer, Section 16 Officers and other officers who report directly to the Chief Executive Officer.

Composition and Qualifications

The Committee shall be comprised of three or more directors, the exact number to be determined from time to time by resolution of the Board. Each member of the Committee shall be "independent" as required by Nasdaq Rules and any other legal requirements as shall from time to time be in effect. The Board of Directors shall, in the exercise of business judgment, determine the "independence" of directors for this purpose.

Members of the Committee shall also qualify as "non-employee directors" within the meaning of Rule 16b-3 promulgated under the Securities Exchange Act of 1934, as amended.

The Chairman of the Committee shall be designated by no less than a majority of the entire Board.

Members of the Committee shall be designated at least annually by no less than a majority of the entire Board (after considering any recommendations of the Corporate Governance Committee).

Vacancies on the Committee shall be filled by no less than a majority of the entire Board. By no less than a majority of the entire Board, a member of the Committee may be removed. Resignation or removal of a director from the Board, for whatever reason, shall automatically constitute resignation or removal, as applicable, from the Committee.

The Chairman of the Committee is responsible for the orientation of new members regarding compensation matters.

Structure and Operation

1. Two members of the Committee shall constitute a quorum. When more than two members are present, the act of a majority of the members present at a meeting at which a quorum is present shall be the act of the Committee, and when only two members are present, the unanimous vote of the two members shall constitute the act of the Committee.
2. The Committee may form and delegate authority to subcommittees when appropriate and to the extent permitted under the By-Laws of the Company, the Company's Corporate Governance Guidelines, law, regulation or Nasdaq Rules.
3. The Secretary of the Company, or in the absence of the Secretary, such person as may be designated by the Chairman of the Committee, shall act as secretary and keep the minutes of all meetings of the Committee.
4. The Committee shall meet in person or telephonically, at least three times a year at such times and places determined by the Chairman of the Committee, with further meetings to occur, or actions to be taken by unanimous written consent, when deemed necessary or desirable by the Committee or its Chairman.
5. The Committee shall meet in executive session without the presence of any members of management as often as it deems appropriate.
6. The Committee may request that any directors, officers or employees of the Company, or other persons whose advice and counsel are sought by the Committee, attend any meeting of the Committee to provide such pertinent information as the Committee requests.
7. The Chairman of the Committee shall report to the Board at each meeting of the Board the deliberations, actions and recommendations of the Committee since the last Board meeting.
8. Except as expressly provided in this charter, the By-Laws of the Company or the Company's Corporate Governance Guidelines, or as required by law, regulations or Nasdaq Rules, the Committee shall establish its own rules of procedure.
