#### THE CHALLENGE

Fairfield Chair Company had a paper problem. Hundreds of file cabinets. Bookshelves and binders beyond count. And four concrete, fireproof safes for payroll alone. Its three-story headquarters in Lenoir, North Carolina, was filled to the brim, forcing employees to share space, with two or three people to an office.

The company's over reliance on paper also made it difficult to respond quickly to customer requests. Pulling files took too much time. And employees often needed to climb three flights of stairs to find what they needed.

To stay relevant in today's fast-paced, digitalfirst marketplace, Fairfield realized the time had come for them to make a change.

#### THE SOLUTION

Fairfield set the goal to digitize at least 60% of their operation within two years and reached out to a local document solutions company, Business Data Solutions, Inc. to research and identify possible solutions. They wanted an enterprise content management solution that could help their office go fully paperless. Instant access to files. The best possible security. Most importantly, the company wanted to get started fast — so high-speed scanning with easy information capture was a must.

Of the four possible options the solutions company recommended, Enterprise Capture — Xerox® DocuShare® with ABBYY capture integration — was the clear choice for Fairfield. With DocuShare® and ABBYY, Fairfield is already making massive strides in its digital transformation journey. Optical character recognition (OCR) is able to capture all types of files and turn them into searchable PDFs — from Microsoft Excel cost summary sheets to checks — and the solution automatically links the captured information to the appropriate customer number. The company is also planning to use DocuShare® to store digital fabric samples. All data is securely backed up on-site and can be accessed with a simple search.

Fairfield is also printing smarter with Xerox. The company has replaced dozens of outdated personal printers with three new Xerox® AltaLink® and and WorkCentre® multifunction printers for office functions and marketing.
