## What is the Voluntary Product Accessibility Template (VPAT)?

The purpose of the Voluntary Product Accessibility Template is to assist Federal contracting officials in making preliminary assessments regarding the availability of commercial Electronic and Information Technology products and services with features that support accessibility. It is assumed that offerers will provide additional contact information to facilitate more detailed inquiries.

The first table of the Template provides a summary view of the section 508 Standards. The subsequent tables provide more detailed views of each subsection. There are three columns in each table. Column one of the Summary Table describes the subsections of subparts B and C of the Standards. The second column describes the supporting features of the product or refers you to the corresponding detailed table, "e.g., equivalent facilitation." The third column contains any additional remarks and explanations regarding the Versant 3100. In the subsequent tables, the first column contains the lettered paragraphs of the subsections. The second column describes the supporting features of the Versant 3100 with regard to that paragraph. The third column contains any additional remarks and explanations regarding the Versant 3100.

## User Tasks Assessed

---

For the Xerox Versant 3100 , general user tasks were assumed to be xxx, yyy, and zzz (e.g., programming and running jobs, unloading prints).
